7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **J.D. Williamson Construction Co., Inc. for the Wright Road Bridge Replacement Project,**
9 **in Copley Township, in Council District 5, in an amount not to exceed \$701,371.70, for the**
10 **Engineer, and declaring an emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized
13 the County Executive to advertise as needed for bridge engineering and construction projects,
14 and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program,
15 and federal and state funded projects, for an estimated total cost not to exceed \$5,290,750.00;
16 and

18 WHEREAS, said projects were approved as part of the Capital Improvements Program
19 for 2020-2025 by Resolution No. 2020-027; and

21 WHEREAS, the current Wright Road Bridge is deteriorating and had to be closed in
22 February 2020 because of repeated illegal truck traffic on the structurally deficient bridge; and

23
24 WHEREAS, the County Engineer has secured funding for 2020 from the County
25 Engineer's Association of Ohio that will cover 80% of the cost of replacing the Bridge through
26 Local Bridge Program funds; and

28 WHEREAS, the amount allocated for bidding the Wright Road Bridge Replacement
29 Project was an estimated amount not to exceed \$745,000.00; and

30
31 WHEREAS, following the receipt and review of bids, the County Executive has proposed
32 entering into a construction contract with J.D. Williamson Construction Co., Inc. for the Wright
33 Road Bridge Replacement Project, in the Copley Township, in Council District 5, in an amount
34 not to exceed \$701,371.70; and

36 WHEREAS, the Board of Control, at its meeting held on March 25, 2020, awarded a
37 construction contract with J.D. Williamson Construction Co., Inc. for the Wright Road Bridge
38 Replacement Project, in Copley Township, in Council District 5, in an amount not to exceed
39 \$701,371.70, subject to confirmation by County Council; and

41 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
42 that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. for the
43 Wright Road Bridge Replacement Project is necessary and in the best interest of the County of
44 Summit;

46 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

6 The award by the Board of Control of construction contract with J.D. Williamson
7 Construction Co., Inc. for the Wright Road Bridge Replacement Project, in Copley Township, in
8 Council District 5, in an amount not to exceed \$701,371.70, is hereby confirmed and the County
9 Executive is hereby authorized to execute such construction contract and any other necessary
10 related documents.

14 This Resolution is hereby declared an emergency in the interest of the health, safety and
15 welfare of the residents of the County of Summit, and for the further purpose to immediately
16 authorize a necessary construction contract for the replacement of the Wright Road Bridge.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 It is found and determined that all formal actions of this Council concerning and relating
28 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
29 deliberations of this Council and of any of its committees that resulted in such formal action,
