A Resolution confirming the award by the Board of Control of a construction contract with J.D. Williamson Construction Co., Inc. for the Wright Road Bridge Replacement Project, in Copley Township, in Council District 5, in an amount not to exceed \$701,371.70, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized the County Executive to advertise as needed for bridge engineering and construction projects, and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program, and federal and state funded projects, for an estimated total cost not to exceed \$5,290,750.00; and

WHEREAS, said projects were approved as part of the Capital Improvements Program for 2020-2025 by Resolution No. 2020-027; and

WHEREAS, the current Wright Road Bridge is deteriorating and had to be closed in February 2020 because of repeated illegal truck traffic on the structurally deficient bridge; and

WHEREAS, the County Engineer has secured funding for 2020 from the County Engineer's Association of Ohio that will cover 80% of the cost of replacing the Bridge through Local Bridge Program funds; and

WHEREAS, the amount allocated for bidding the Wright Road Bridge Replacement Project was an estimated amount not to exceed \$745,000.00; and

WHEREAS, following the receipt and review of bids, the County Executive has proposed entering into a construction contract with J.D. Williamson Construction Co., Inc. for the Wright Road Bridge Replacement Project, in the Copley Township, in Council District 5, in an amount not to exceed \$701,371.70; and

WHEREAS, the Board of Control, at its meeting held on March 25, 2020, awarded a construction contract with J.D. Williamson Construction Co., Inc. for the Wright Road Bridge Replacement Project, in Copley Township, in Council District 5, in an amount not to exceed \$701,371.70, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. for the Wright Road Bridge Replacement Project is necessary and in the best interest of the County of Summit;
