7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**
8 **professional service contract with AllOne Health Resources, Inc. (Ease@Work) for**
9 **Employee Assistance Program services for County employees and employees of other**
10 **participating political subdivisions, for a one-year term, from 1/1/20 through 12/31/20, for**
11 **an amount not to exceed \$123,452.00, for the Executive's Department of Human Resources,**
12 **and declaring an emergency**

14 WHEREAS, County Council previously adopted Resolution No. 2018-321, which
15 confirmed the award by the Board of Control of a professional service contract with The Centers
16 for Families and Children d.b.a. Ease@Work for Employee Assistance Program ("EAP")
17 services for County employees and employees of other participating political subdivisions, for a
18 one-year term, from 1/1/19 through 12/31/19, with two options to renew for an additional one-
19 year term, for an amount not to exceed \$18.30 per employee per year, for a total amount not to
20 exceed \$123,452.00; and

22 WHEREAS, County Council subsequently adopted Resolution No. 2019-321, which
23 approved the assignment of the professional service contract between the County and The
24 Centers for Families and Children d.b.a. Ease@Work for EAP services to AllOne Health
25 Resources Inc., including the two renewals of said contract approved by Resolution No. 2018-
26 321; and

28 WHEREAS, the Board of Control, at its meeting held March 25, 2020, awarded a
29 renewal (first of two) of a professional service contract with AllOne Health Resources, Inc.
30 (Ease@Work) for EAP services for County employees and employees of other participating
31 political subdivisions, for a one-year term, from 1/1/20 through 12/31/20, for an amount not to
32 exceed \$18.30 per employee per year, for a total amount not to exceed \$123,452.00, subject to
33 confirmation by County Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that the aforementioned renewal (first of two) of a professional service contract with AllOne
37 Health Resources, Inc. is necessary and in the best interest of the County of Summit;

44 The award by the Board of Control of a renewal (first of two) of a professional service
45 contract with AllOne Health Resources, Inc. (Ease@Work) for Employee Assistance Program
46 ("EAP") services for County employees and employees of other participating political
47 subdivisions, for a one-year term, from 1/1/20 through 12/31/20, for an amount not to exceed
48 \$18.30 per employee per year, for a total amount not to exceed \$123,452.00, is hereby confirmed
49 and the County Executive is hereby authorized to execute such professional service contract and
50 any other necessary related documents.
