A Resolution confirming an award by the Board of Control of a purchase contract with R.J. Beck Protective Systems, Inc., at GSA pricing, for the purchase of camera upgrades for the City of Green Local School District, in an amount not to exceed \$57,973.23, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2019-360, which confirmed an award by the Board of Control of a purchase contract with R.J. Beck Protective Systems, Inc., at GSA pricing, for the purchase of an alarm system for the City of Green Local School District, in an amount not to exceed \$145,028.27; and

WHEREAS, said purchase was funded by a grant from the U.S. Department of Justice Community Oriented Policing Services ("COPS") Office Stop School Violence Prevention Program Grant previously accepted by the County pursuant to Resolution No. 2018-457; and

WHEREAS, the County Sheriff seeks to enter into a purchase contract with R.J. Beck Protective Systems, Inc., at GSA pricing, for the purchase of camera upgrades for the City of Green Local School District, in an amount not to exceed \$57,973.23; and

WHEREAS, said purchase will be funded by a grant from the U.S. Department of Justice COPS School Violence Prevention Program Grant previously accepted by the County; and

WHEREAS, the Board of Control, at its meeting held March 11, 2020, awarded a purchase contract with R.J. Beck Protective Systems, Inc., as GSA pricing, for the purchase of camera upgrades for the City of Green Local School District, in an amount not to exceed \$57,973.23, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with R.J. Beck Protective Systems, Inc. is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a purchase contract with R.J. Beck Protective Systems, Inc., at GSA pricing, for the purchase of camera upgrades for the City of Green Local School District, in an amount not to exceed \$57,973.23, is hereby confirmed and the County Executive is hereby authorized to execute such purchase contract and any other necessary related documents.
