7 **A Resolution confirming an award by the Board of Control of a blanket purchase order**
8 **with Ports Petroleum Co., Inc., at State Term pricing, for unleaded gasoline and diesel fuel**
9 **for general fleet operations and standby generators, in an amount not to exceed \$60,000.00,**
10 **for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held on March 4, 2020, awarded a
13 blanket purchase order with Ports Petroleum Co., Inc., at State Term pricing, for unleaded
14 gasoline and diesel fuel for general fleet operations, in an amount not to exceed \$60,000.00,
15 subject to confirmation by County Council; and

17 WHEREAS, the County Executive's Department of Sanitary Sewer Services uses
18 unleaded gasoline and diesel fuel in vehicles and standby generators, which requires the County
19 to purchase unleaded gasoline and diesel fuel; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the blanket purchase order with Ports Petroleum Co., Inc., for unleaded gasoline and diesel
23 fuel for general fleet operations and standby generators is necessary and in the best interest of the
24 County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The award by the Board of Control of a blanket purchase order with Ports Petroleum Co.,
32 Inc., at State Term pricing, for unleaded gasoline and diesel fuel for general fleet operations and
33 standby generators, in an amount not to exceed \$60,000.00, is hereby confirmed and the County
34 Executive is hereby authorized to execute such blanket purchase order and any other necessary
35 related documents.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the residents of the County of Summit, and for the further reason to immediately
41 provide unleaded gasoline and diesel fuel for general fleet operations and standby generators at
42 the Executive's Department of Sanitary Sewer Services.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.


