WHEREAS, the Board of Control, at its meeting held on March 4, 2020, awarded a purchase contract to Cargill, Incorporated, at CUE pricing. for road salt for the 2020 snow and ice control season, in an amount not to exceed \$745,500.00, subject to confirmation by County Council; and

WHEREAS, it is necessary for the County Engineer to purchase road salt as needed for snow and ice control on County roadways for the remaining 2020 snow and ice control season; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Cargill Incorporated is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The award by the Board of Control of a purchase contract with Cargill, Incorporated, at CUE pricing, for road salt for the 2020 snow and ice control season, in an amount not to exceed \$745,500.00, is hereby confirmed and the County Executive is hereby authorized to execute such purchase contract and any other necessary related documents.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide for road salt for the 2020 snow and ice control season.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
