7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Tri-County Jobs for Ohio’s Graduates for Summer Youth Employment**
9 **Program monitoring services, work readiness skills training, and other additional services,**
10 **for the period 4/1/20 through 9/30/20, in a total amount not to exceed \$95,000.00, for the**
11 **Executive’s Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 11, 2020, awarded a
14 professional service contract with JOG for SYEP monitoring services, work readiness skills
15 training, and other additional services, for the period 4/1/20 through 9/30/20, in a total amount
16 not to exceed \$95,000.00, subject to confirmation by County Council; and

18 WHEREAS, the County Executive’s Department of Job and Family Services seeks to
19 enter into a professional service contract with Tri-County Jobs for Ohio’s Graduates (“JOG”) for
20 Summer Youth Employment Program (“SYEP”) monitoring services, work readiness skills
21 training, and other additional services; and

23 WHEREAS, under the professional service contract, JOG will be responsible for
24 employer recruitment, youth job matching, filling job slots, site monitoring, picking up time
25 sheets to be sent to a payroll vendor, general supervision of the youth and troubleshooting day-
26 to-day issues; and

28 WHEREAS, under the professional service contract, JOG will also be responsible for
29 adhering to reporting requirements, providing oversight of supervisory staff, work readiness
30 skills training and general guidance to youth who are assigned to various work experience sites
31 throughout Summit County; and

33 WHEREAS, this Council finds and determines after reviewing all pertinent information
34 that the aforementioned professional service contract with JOG for SYEP monitoring services,
35 work readiness skills training, and other additional services, is necessary and in the best interest
36 of the County of Summit;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
