WHEREAS, the Akron Urban League ("AUL") has requested, and the County of Summit has agreed to provide professional and financial services to the AUL in the form of a loaned executive; and

WHEREAS, the AUL shall agree to reimburse the County the employment costs for said loaned executive; and

WHEREAS, the County has made a substantial financial investment in the AUL over the past several years, including the refinancing of its headquarters facility, and desires to assist the AUL in its efforts to be financially well managed; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that authorizing the County Executive to execute the aforementioned professional service contract with the AUL is necessary and in the best interest of the County of Summit for the aforementioned reason;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The County Executive is hereby authorized to execute a professional service contract with the Akron Urban League ("AUL") to provide professional and financial services to the AUL and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of Summit County, and for the further reason to immediately authorize a necessary professional service contract with the AUL, so that the County may provide the AUL with professional and financial services as soon as possible.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
