WHEREAS, the Board of Control, at its January 15, 2020 meeting, awarded a professional service contract with Sadler-NeCamp Financial Services, Inc. dba Proware, as a Sole Source, approved by the IT Board on 1/9/20, for case management system software support and maintenance services, for a one-year term, from 1/1/20 through 12/31/20, for an amount not to exceed \$156,110.00 for the first year, with four options to renew for an additional one-year term, for a total cost not to exceed \$818,030.00 for the five-year period, subject to confirmation by County Council; and
