A Resolution confirming an award by the Board of Control of a professional service contract with PNC Bank, N.A. and PNC Merchant Services Company, as a Best Practical Source, for merchant services and credit card/bank card processing services, for a three-year term, at no cost to the County, for the Clerk of Courts, and declaring an emergency.

WHEREAS, the Board of Control, at its meeting held December 11, 2019, awarded a a professional service contract with PNC Bank, N.A. and PNC Merchant Services Company, as a Best Practical Source, to deliver retail point of sale and e-commerce online transactions for customers of the Clerk's Office, for a three-year term, at no cost to the County; and

WHEREAS, this Council previously adopted Resolution 2017-315 designating Key Bank N.A., JP Morgan Chase Bank, N.A., Huntington National Bank, PNC Bank N.A., Fifth Third Bank, Citizens Bank N.A. and Westfield Bank FSB as depositories of active moneys of the County, for the period 9/1/17 through 8/31/21; and

WHEREAS, the County's current merchant services vendor, Banc of America Merchant Services, LLC, is dissolving and phasing out its merchant services branch in 2020; and

WHEREAS, PNC Banks has served as the depository for the Clerk of Courts since 2009 and the Clerk wishes to move merchant services and credit card/bank card processing services as a result of Bank America discontinuing its merchant services branch; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with PNC Bank, N.A. and PNC Merchant Services is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio. that:

SECTION 1

The award by the Board of Control of a professional service contract with PNC Bank, N.A. and PNC Merchant Services Company, as a Best Practical Source, for merchant services and credit card/bank card processing services, for a three-year term, at no cost to the County, is hereby confirmed, and the County Executive is hereby authorized to execute said professional service contract and any other related necessary documents.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that it immediately provides for necessary merchant services for the Clerk of Courts in 2020.
