WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a grant agreement with The Ohio State University for the aforementioned grant for programs through its Summit County Extension Office, in an amount not to exceed \$152,800.00, for the year 2020;
