7 **A Resolution authorizing the County Executive to execute a grant agreement with the**
8 **Victim Assistance Program, for a grant for victim assistance services, in an amount not to**
9 **exceed \$30,000.00, for the year 2020, for the Executive's Department of Finance and**
10 **Budget, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Amended Resolution No. 2019-439, which,
13 as part of the 2020 General Fund Budget, appropriated funds in Account No. 10003-8017-65111,
14 in an amount not to exceed \$30,000.00, for a grant to the Victim Assistance Program for victim
15 assistance services; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that it is necessary and in the best interest of the County of Summit to authorize the County
19 Executive to execute a grant agreement with the Victim Assistance Program, for the
20 aforementioned grant for victim assistance services, in an amount not to exceed \$30,000.00, for
21 the year 2020;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

28 The County Executive is hereby authorized to execute a grant agreement with the Victim
29 Assistance Program for a grant for victim assistance services, in an amount not to exceed
30 \$30,000.00, for the year 2020. Said grant will be paid out of account number 10003-8017-
31 65111.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the residents of the County of Summit, and for the further reason that the County
37 wishes to immediately provide support through a grant to the Victim Assistance Program for
38 victim assistance services for the year 2020.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,




