WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a grant agreement with the Victim Assistance Program, for the aforementioned grant for victim assistance services, in an amount not to exceed \$30,00.000, for the year 2020;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The County Executive is hereby authorized to execute a grant agreement with the Victim Assistance Program for a grant for victim assistance services, in an amount not to exceed \$30,000.00, for the year 2020. Said grant will be paid out of account number 10003-8017-65111.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that the County wishes to immediately provide support through a grant to the Victim Assistance Program for victim assistance services for the year 2020.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
