8 **A Resolution confirming an award by the Board of Control of a purchase contract with**
9 **ICOR Technology, Inc., as lowest responsive and responsible bidder, for a robot for the**
10 **Mansfield Police Department Special Weapons and Tactics Team and the Richland County**
11 **Allied Special Operations Response Team, in an amount not to exceed \$68,080.00, for the**
12 **Executive's Department of Law and Risk Management-Division of Public Safety, and**
13 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its December 11, 2019 meeting, awarded a
15 purchase contract with ICOR Technology, Inc., as lowest responsive and responsible bidder, for
16 a robot for the Mansfield Police Department SWAT Team and the Richland County ASORT, in
17 an amount not to exceed \$68,080.00, subject to confirmation by County Council; and

18
19 WHEREAS, this Council previously adopted Resolution No. 2019-304, which authorized
20 the County Executive to advertise for bids for a robot for the Mansfield Police Department
21 Special Weapons and Tactics Team ("SWAT") and the Richland County Allied Special
22 Operations Response Team ("ASORT") in support of Ohio Homeland Security Region 5 and the
23 10county METRICH region, to enhance capabilities during a high risk incident, for an estimated
24 total cost not to exceed \$70,240.00; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned purchase contract with ICOR Technology, Inc. is necessary and in the
28 best interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a purchase contract with ICOR Technology, Inc.,
36 as lowest responsive and responsible bidder, for a robot for the Mansfield Police Department
37 Special Weapons and Tactics Team ("SWAT") and the Richland County Allied Special
38 Operations Response Team ("ASORT"), in an amount not to exceed \$68,080.00, is hereby
39 confirmed, and the County Executive is hereby authorized to execute said purchase contract and
40 any other related necessary documents.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit, and for the further reason that it immediately
46 provides for necessary equipment for the Mansfield Police SWAT and the Richland County
47 ASORT to protect the public.


