A Resolution authorizing the County Executive to execute any documents necessary to accept the award from the Ohio Department of Public Safety's Office of Criminal Justice Services of an Edward Byrne Memorial Justice Assistance grant, for the period 1/1/15 through 12/31/15, in the amount of \$39,998.01, with a 25% local cash match requirement of \$13,332.68, and appropriating funds in the amount of \$53,330.69, for Fiscal Year 2015, for the Sheriff, and declaring an emergency.

WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services ("ODPS-OCJS") has awarded the County Sheriff's Office an Edward Byrne Memorial Justice Assistance grant, for the period 1/1/15 through 12/31/15, in the amount of \$39,998.01 with a 25% local cash match requirement of \$13,332.68; and

WHEREAS, this Edward Byrne Memorial Justice Assistance grant will fund a countywide drug unit task force which will specifically target the manufacture, distribution and acquisition of illegal drugs in Summit County; and

WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit County Drug Unit checking account; and

WHEREAS, it is necessary to appropriate funds in the amount of \$53,330.69; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute any documents necessary to accept the award of the aforementioned Edward Byrne Memorial Justice grant from the ODPS-OCJS, and to appropriate grant funds and the local cash match;
