A Resolution authorizing the County Executive to execute a Fifth Amendment to the Agreement of Sublease with the Ohio Department of Rehabilitation and Correction, pertaining to the finance of capital improvements to the Summit County Community Based Correctional Facility, for the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety, and declaring an emergency.

WHEREAS, the County entered into an Agreement of Sublease with the Ohio Department of Rehabilitation and Correction ("ODRC"), made as of 8/1/95, pursuant to Resolution No. 95-470, amended and supplemented by the First Amendment to Agreement to Sublease, made as of 12/1/96, pursuant to Resolution No. 96-670, the Second Amendment to Agreement to Sublease, made as of 4/1/00, pursuant to Resolution No. 2000-210, the Third Amendment to Agreement of Sublease, made as of 12/1/00, pursuant to Resolution No. 2000-784 and the Fourth Amendment to Agreement of Sublease, made as of 4/1/09, pursuant to Resolution No. 2009-089 (collectively "Sublease") pertaining to the finance of capital improvements to the Summit County Community Based Correctional Facility ("CBCF") located at 246 East Crosier Street, Akron, Ohio 44311, in Council District 5; and

WHEREAS, the ODRC has awarded the County of Summit \$450,000 in capital improvement funds to make repairs to the foundation of the CBCF, which requires amendment of the Sublease (Project No. 15-CBCF-002); and

WHEREAS, County and ODRC desire to amend the Sublease with the consent of the Ohio Building Authority ("Authority") in accordance with the terms of a Fifth Amendment to the Sublease; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the Fifth Amendment of the aforementioned Sublease;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute the Fifth Amendment to the Agreement of Sublease with the Ohio Department of Rehabilitation and Correction.

SECTION 2

The proper officers of the County and this Council, as appropriate, are each authorized and directed to deliver any additional certificates, documents or instruments and to take such further actions which are necessary or appropriate to effect the intent and purposes of this Resolution and the Fifth Amendment to the Sublease.
