WHEREAS, the Commission is authorized by Section 120.14 of the ORC to contract with a non-profit organization to provide legal services to indigent persons; and		
WHEREAS, the Commission wishes to contract with the Legal Defenders Office of Summit County, Ohio, Inc., a not-for-profit corporation, to provide legal representation to indigent persons on behalf of the Commission from 1/1/15 to 12/31/15, for an amount not to exceed \$535,100.00; and		
WHEREAS, the County Executive is required to execute the aforementioned contract, the cost of which will be paid out of funds appropriated by Council in Account No. 10003-2711-45501 pursuant to Resolution No. 2014-515; and		
WHEREAS, said professional service contract with the Legal Defenders Office of Summit County, Inc., is subject to the approval of the Board of Control; and		
WHEREAS, this County Council finds and determines, after reviewing all pertinent information, that it is necessary and in the interest of the County of Summit to authorize the Executive to execute the aforementioned contract with the Legal Defenders Office of Summit County, Ohio, Inc., subject to the approval of the Board of Control;
