A Resolution authorizing the County Executive to execute a services agreement with the Development Finance Authority of Summit County ("DFA") to provide construction administrator services to the DFA for the DFA's ODOT Vertical Building Project in Medina County, for the Executive's Department of Administrative Services, and declaring an emergency.

WHEREAS, the Ohio Department of Transportation ("ODOT") has contracted with the Ohio Council of Port Authorities ("OCPA") for OCPA to construct certain ODOT vertical building projects throughout the State of Ohio; and,

WHEREAS, as a member of OCPA, the DFA has applied for, and been selected to construct, an ODOT vertical building project in Medina County in cooperation with the Medina County Port Authority ("Medina Project") at an estimated cost of \$8.6 million; and

WHEREAS, the DFA desires to contract with the County for the provision of construction administrator services by the County Executive's Department of Administrative Services for the Medina Project, and pay the County a fee equal to 2.4% of the Medina Project's total construction cost for said services; and

WHEREAS, pursuant to General Provision 9.482 of the Ohio Revised Code, the County and DFA are authorized to enter the aforementioned contract; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary, and in the best interest of the County to authorize the County Executive to execute the aforementioned contract.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
