A Resolution authorizing the Court of Common Pleas General Division to make expenditures in an amount not to exceed \$10,000.00 for hospitality items incurred in providing training and planning sessions, to be held in 2015, for the Court of Common Pleas General Division, and declaring an emergency.

WHEREAS, the Court of Common Pleas General Division conducts training and planning sessions, board meetings and other staff training and/or meetings as deemed necessary by the Court; and

WHEREAS, such training and planning sessions, board meetings and other staff training and/or meetings are attended by county employees, outside organizations and elected officials; and

WHEREAS, the Court of Common Pleas General Division wishes to pay hospitality expenses, in an amount not to exceed \$10,000.00 for 2015 related to the aforementioned training and planning sessions; and

WHEREAS, the Office of the Attorney General of the State of Ohio issued Opinion No. 82-006, which authorizes the expenditure of funds by a local political subdivision for its employees as long as those expenditures are necessary to further a public purpose and if the political subdivision's determination to make such expenditures is not manifestly arbitrary or unreasonable; and

WHEREAS, Section 177.24 (b) and (c) of the Codified Ordinances of the County of Summit require the approval of County Council for hospitality expenditures exceeding \$2,000.00 per year and for hospitality expenditures for purposes other than employee training, meetings and organization strategic planning meetings; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize and ratify the Court of Common Pleas General Division expenditures, in an amount not to exceed \$10,000.00, for hospitality items incurred in providing training and planning sessions to be held in 2015 and that such expenditures are for a valid public purpose;
