A Resolution authorizing the County Executive to execute a three-year policing contract with Northfield Center Township, in Council District 1, for the period 1/1/15 through 12/31/17, in exchange for payment by Northfield Center Township of a total amount of \$2,361,266.14, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2011-362, which authorized the County Executive to execute a three-year policing contract with Northfield Center Township in Council District 1, which expired on 12/31/14; and

WHEREAS, Northfield Center Township has requested that the County of Summit enter into a new contract pursuant to which the County Sheriff will provide 11,746.87 deputy/sergeant hours, for the period 1/1/15 through 12/31/17, and

WHEREAS, Northfield Center Township has agreed to pay the County \$769,287.09 for the first year, \$787,258.53 for the second year and \$804,720.52 for the third year, for a total amount of \$2,361,266.14 during the three-year term of the contract; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned policing contract with Northfield Center Township;
