	WHEREAS, as part of its operation, it is necessary for the Board to purchase a contract		

WHEREAS, as part of its operation, it is necessary for the Board to purchase a contract for online legal research services; and

WHEREAS, at its October 23, 2014 meeting, the Law Library Resources Board approved a professional service contract with Thomson West (Westlaw), as Best Practical Source, for online legal research services for Law Library patrons, for a three-year term, from 1/1/15 through 12/31/17, for an amount not to exceed of \$2,662.66 per month for the first year, with 3% increases in the second year and third years, for a total not to exceed amount of \$98,760.24 for the three-year term; and

SECTION 1

The award by the Board of Control of a three-year professional service contract with Thomson West (Westlaw), as Best Practical Source, for online legal research services for Law Library patrons, for a three-year term, from 1/1/15 through 12/31/17, for an amount not to exceed of \$2,662.66 per month for the first year, with 3% increases in the second year and third years, for a total not to exceed amount of \$98,760.24 for the three-year term, is hereby confirmed and the County Executive is authorized to execute said contract.

SECTION 2
