SECTION 1

The County Executive is hereby authorized to execute the First Amendment to a professional service contract with URS Corporation to make necessary repairs to the heating, ventilating and air conditioning system at the Summit County Jail, namely, to remove a 4-inch bypass line and install a new 6-inch line and valve in the chilled water mains in the first floor mechanical room at the Summit County Jail, located in the City of Akron, in Council District 4, to resolve ongoing problems with the chillers, at no additional cost to the County.

SECTION 2

The County Executive is hereby authorized to execute a Settlement Agreement and Release with URS Corporation concerning these repairs to the heating, ventilating and air conditioning system at the Summit County Jail; to resolve ongoing problems with the chillers; pursuant to which URS Corporation will pay Cahill Corporation the amount of \$14,675.00.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize the Executive to execute the First Amendment to the professional service contract with URS Corporation and the related Settlement Agreement and Release to effect necessary repairs at the Summit County Jail.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 5

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
