7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Kenmore Construction Company, Inc., for an emergency sanitary sewer repair on the**
9 **Pump Station 38 force main, in an amount not to exceed \$41,728.35, for the Executive's**
10 **Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 25, 2015, awarded a
13 construction contract with Kenmore Construction Company, Inc., for an emergency sanitary
14 sewer repair on the Pump Station 38 force main, in Council District 4, subject to confirmation by
15 County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a construction contract with Kenmore Construction
26 Company, Inc., for an emergency sanitary sewer repair on the Pump Station 38 force main, in
27 Council District 4, in an amount not to exceed \$41,728.35, is hereby confirmed and the County
28 Executive is hereby authorized to execute such contract.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 authorize the emergency sanitary sewer repair in Council District 4.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
47 were in meetings open to the public, in compliance with all legal requirements, including Section
48 121.22 of the Ohio Revised Code.






