7 **A Resolution confirming an award by the Board of Control of an intergovernmental**  
8 **agreement with the County of Summit Sheriff's Office for building security and fraud**  
9 **investigation services, for the period 7/1/15 to 6/30/16, in an amount not to exceed**  
10 **\$737,523.90, for the Executive's Department of Job and Family Services, and declaring an**  
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 25, 2015, awarded an  
14 intergovernmental agreement with the County of Summit Sheriff's Office for building security  
15 and fraud investigation services, for the period 7/1/15 through 6/30/16, subject to confirmation  
16 by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the agreement is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of an intergovernmental agreement with the County  
27 of Summit Sheriff's Office for building security and fraud investigation services, for the period  
28 7/1/15 to 6/30/16, in an amount not to exceed \$737,523.90, is hereby confirmed and the County  
29 Executive is hereby authorized to execute such agreement.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
35 provide building security and fraud investigation services effective 7/1/15.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

43 SECTION 4

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.
