7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of an Edward Byrne Memorial Justice Assistance grant from the Ohio**
9 **Department of Public Safety's Office of Criminal Justice Services, for the period 1/1/15**
10 **through 12/31/15, in the amount of \$33,332.02, with a 50% local cash match requirement,**
11 **and appropriating funds, in the amount of \$66,664.04, for the Common Pleas-General**
12 **Division, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services
15 ("ODPS-OCJS") has awarded the Common Pleas Court-General Division an Edward Byrne
16 Memorial Justice Assistance grant, for the period 1/1/15 through 12/31/15, in the amount of
17 \$33,332.02 with a 50% local cash match requirement of \$33,332.02; and

19 WHEREAS, this Edward Byrne Memorial Justice Assistance grant will assist agencies
20 with implementation of programs designed to improve the domestic lifestyle of residents of
21 Summit County; and

23 WHEREAS, the Domestic Violence Court grant requires a local cash match requirement
24 in the amount of \$33,332.02, which will be provided by the Court's General Fund and will help
25 support staff benefits costs and program supply needs for the operation of this grant; and

27 WHEREAS, it is necessary to appropriate funds, in the amount of \$66,664.04; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the County
31 Executive to execute any documents necessary to accept the award of the aforementioned
32 Edward Byrne Memorial Justice grant from the ODPS-OCJS, and to appropriate grant funds and
33 the local cash match;




