WHEREAS, this OHRAB grant is to restore, preserve, digitize and index ten Edwin Shaw scrapbooks; and

WHEREAS, the NHPRC grant requires an in-kind match in the amount of \$4,503.00, which will be provided by The University of Akron, the County of Summit and Summit County Historical Society staff and will help support staff costs and program supply needs for the operation of this grant; and

WHEREAS, it is necessary to appropriate funds in the amount of \$2,000.00; and
