WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the purchase order is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a purchase order with the Village of Mogadore for reimbursement/payment of construction costs for rehabilitation of sanitary sewers during the Highland Drive Reconstruction Project, in Council District 8, in an amount not to exceed \$70,670.00, is hereby confirmed and the County Executive is hereby authorized to execute such purchase order.
