7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award from the State of Ohio Department of Rehabilitation and Correction,**  
9 **through the Community Corrections Act, of a 407 grant for State Fiscal Year 2016, in the**  
10 **amount of \$1,239,107.00, with no local cash match requirement, for the period 7/1/15**  
11 **through 6/30/16, and appropriating grant funds, for the Executive’s Department of Law,**  
12 **Insurance and Risk Management – Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (“ODRC”),  
15 through the Community Corrections Act (“CCA”) grant program, has renewed the award to the  
16 County of Summit of a 407 grant for State Fiscal Year (“SFY”) 2016, in the amount of  
17 \$1,239,107.00, with no local cash match requirement, for community corrections programs to be  
18 operated by the Summit County Adult Probation Department and Oriana House, Inc., for the  
19 period 7/1/15 through 6/30/16, and

21 WHEREAS, it is necessary for the County Executive to execute documents necessary to  
22 accept the grant award and to appropriate grant funds; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 execute any documents necessary to accept the CCA 407 grant funds in the amount of  
27 \$1,239,107.00, with no local cash match requirement, for SFY 2016, and to appropriate grant  
28 funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 the award from the State of Ohio Department of Rehabilitation and Correction (“ODRC”),  
37 through the Community Corrections Act (“CCA”) grant program, of a 407 grant for State Fiscal  
38 Year (“SFY”) 2016, in the amount of \$1,239,107.00, with no local cash match requirement, for  
39 community corrections programs to be operated by the Summit County Adult Probation  
40 Department and Oriana House, Inc., for the period 7/1/15 through 6/30/16.


SECTION 6
