A Resolution authorizing the County Executive to execute any documents necessary to accept the award of Community Based Correctional Facility subsidy grant for State Fiscal Year 2016 from the State of Ohio Department of Rehabilitation and Correction for a community based correctional facility to be operated by Oriana House, Inc., for the period 7/1/15 through 6/30/16, in the amount of \$5,452,456.00, with no local cash match requirement, and appropriating grant funds, for the Executive's Department of Law, Insurance and Risk Management – Division of Public Safety, and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC") awarded the County of Summit a Community Based Correctional Facility ("CBCF") subsidy grant for State Fiscal Year ("SFY") 2016 for a CBCF to be operated by Oriana House, Inc., for the period 7/1/15 through 6/30/16, in the amount of \$5,452,456.00, with no local cash match requirement; and

WHEREAS, it is necessary for the County Executive to execute documents to accept the grant award and to appropriate funds; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the Executive to execute any documents necessary to accept the CBCF subsidy grant funds, in the amount of \$5,452,456.00, with no local cash match requirement, for SFY 2016 and to appropriate grant funds;
