A Resolution authorizing the County Executive to execute a one-year renewal agreement with Oriana House, Inc., and the County of Summit Sheriff for the operation of community corrections programs for State Fiscal Year 2016, for the period 7/1/15 through 6/30/16, in an amount not to exceed \$448,759.00, pursuant to which Oriana House, Inc., shall be paid an amount not to exceed \$359,405.00, and the Sheriff's Office shall be paid an amount not to exceed \$89,354.00, for the Executive's Department of Law, Insurance and Risk Management – Division of Public Safety and declaring an emergency.

WHEREAS, the State of Ohio Department of Rehabilitation and Correction, through the Community Corrections Act ("CCA") program has renewed the award to the County of Summit of a 408 grant for State Fiscal Year ("SFY") 2016, for the period of 7/1/15 through 6/30/16, in the amount of \$448,759.00, with no local cash match requirement, for community corrections programs to be operated by Oriana House, Inc., and the County of Summit Sheriff; and

WHEREAS, currently this Council adopted Resolution No. 2015-203, which authorized the County Executive to execute any documents necessary to accept the 408 grant and appropriated grant funds; and

WHEREAS, it is necessary for this Council to authorize the Executive to execute a one-year renewal agreement with Oriana House, Inc., and the County of Summit Sheriff for the operation of community corrections programs for SFY 2016, for the period 7/1/15 through 6/30/16, in an amount not to exceed \$448,759.00, which is funded by a 408 grant through the CCA, pursuant to which Oriana House, Inc., shall be paid an amount not to exceed \$359,405.00, and the Sheriff's Office shall be paid an amount not to exceed \$89,354.00; and
