7 **A Resolution confirming an award by the Board of Control of a purchase order with Key**  
8 **Chrysler Jeep Dodge Ram for one 2015 Dodge Charger police special vehicle, under State**  
9 **Term Pricing, in an amount not to exceed \$25,658.25, for the Sheriff, and declaring an**  
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 22, 2015, awarded a purchase  
13 order with Key Chrysler Jeep Dodge Ram for one unmarked 2015 Dodge Charger police special  
14 vehicle for the Sheriff's Detective Bureau, under State Term Pricing, subject to confirmation by  
15 County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

25 The award by the Board of Control of a purchase order with Key Chrysler Jeep Dodge  
26 Ram for one unmarked 2015 Dodge Charger police special vehicle for the Sheriff's Detective  
27 Bureau, under State Term Pricing, in an amount not to exceed \$25,658.25, is hereby confirmed  
28 and the County Executive is hereby authorized to execute such purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further reason to immediately  
34 provide a replacement vehicle for the Sheriff's Detective Bureau in 2015.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.


