7 **A Resolution authorizing the County's Department of Job and Family Services to transfer**
8 **an amount not to exceed \$700,000.00 in Title XX/TANF funds to Summit County Children**
9 **Services, for the Executive's Department of Job and Family Services, and declaring an**
10 **emergency.**

12 WHEREAS, the County Executive's Department of Job and Family Services ("DJFS") is
13 the recipient of certain Title XX/TANF funds, which it receives as part of its annual allocation;
14 and

15
16 WHEREAS, on September 2, 2014, DJFS received an allocation notice from the State of
17 Ohio, whereby the State set forth the Title XX/TANF allocations for DJFS for the period 10/1/14
18 through 9/30/15; and

19
20 WHEREAS, the September 2, 2014, allocation notice indicates that DJFS has been
21 allocated Title XX/TANF funds in the amount of \$2,725,518.00 for the period 10/1/14 through
22 9/30/15; and

24 WHEREAS, Summit County Children Services ("SCCS") provides protective services
25 for children and emancipating out of foster care services that are eligible expenses for the use of
26 Title XX/TANF funds; and

27
28 WHEREAS, in exchange for providing such services, DJFS will transfer an amount not
29 to exceed \$700,000.00 of Title XX/TANF funds to SCCS to be used for Non-Allocated
30 Children's costs; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorize the transfer of an
34 amount not to exceed \$700,000.00 of Title XX/TANF funds to SCCS, and to authorize the
35 Executive to execute any documents necessary to effectuate said transfer;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

40 SECTION 1

42 The County Executive, through the Department of Job and Family Services, is hereby
43 authorized to transfer an amount not to exceed \$700,000.00 in Title XX/TANF funds to Summit
44 County Children Services ("SCCS") to be used for Non-Allocated Children's Services costs, and
45 the County Executive is further authorized to execute any documents necessary to effectuate said
46 transfer.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for the further reason to immediately
8 authorize the transfer of said Title XX/TANF funds to SCCS.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including Section
22 121.22 of the Ohio Revised Code.
