4 **A Resolution authorizing the County Executive to execute agreements and amendments to**
5 **existing agreements with various local employers for participation and reimbursement**
6 **through the Workforce Innovation Opportunity Act On the Job Training program, in an**
7 **amount not to exceed \$300,000.00 collectively, for the period 7/1/15 through 6/30/16, for the**
8 **Executive's Department of Job and Family Services, and declaring an emergency.**

10 WHEREAS, pursuant to Resolution No. 2014-208, this Council authorized the County
11 Executive to execute agreements with various employers for participation and reimbursement
12 through the Workforce Investment Act On the Job Training ("WIA OJT") program, in an amount
13 not to exceed \$500,000.00 collectively, for the period 7/1/14 through 6/30/15; and

15 WHEREAS, due to the enactment of the Workforce Investment Opportunity Act
16 ("WIOA"), the OJT program will be funded using WIOA funds commencing 7/1/15; and

17
18 WHEREAS, the Executive's Department of Job and Family Services desires to continue
19 the program with an additional \$300,000.00 in WIOA OJT funding, in order to continue
20 reimbursing current and additional employers for newly hired employees, for the period 7/1/15
21 through 6/30/16; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County to authorize the Executive to execute
25 agreements and amendments to existing agreements with various local employers for
26 participation and reimbursement through the WIOA OJT program, in an amount not to exceed
27 \$300,000.00 collectively, for the period 7/1/15 through 6/30/16;

29 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
30 State of Ohio, that:

34 The County Executive is hereby authorized to execute agreements and amendments to
35 existing agreements with various local employers for participation and reimbursement through
36 the Workforce Innovation Opportunity Act On the Job Training ("WIOA OJT") program, in an
37 amount not to exceed \$300,000.00 collectively, for the period 7/1/15 through 6/30/16.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit, and for the further reason to immediately allow
43 the Executive to enter into the any necessary agreements and amendments in order to timely
44 expend the WIOA OJT funds.
