7 **A Resolution, authorizing the County Executive to execute a purchase contract with**
8 **Beacon Software Solutions, Inc., subject to the approval of the Board of Control, for jail**
9 **management system software and support for a six-year term, at lower than State Term**
10 **Pricing, for a total amount not to exceed \$323,568.00, and appropriating funds, for the**
11 **Sheriff, and declaring an emergency.**

13 WHEREAS, the County Sheriff has identified the need to replace the current jail
14 management system used at the Summit County Jail due to obsolescence; and

15
16 WHEREAS, the Summit County Jail Management System project is included in the
17 2015-2020 Capital Improvement Program, which was previously adopted by this Council by the
18 adoption of Resolution 2015-023; and

19
20 WHEREAS, the County Executive and County Sheriff have identified jail management
21 system software and support through Beacon Software Solutions, Inc. as a feasible solution to
22 replace the current jail management system; and

23
24 WHEREAS, the County Executive has negotiated a purchase contract with a six-year
25 term, at an amount not to exceed \$323,568.00 during the term, an amount that is less than State
26 Term Pricing, for jail management system software and support through Beacon Software
27 Solutions, Inc.; and

29 WHEREAS, it is necessary to appropriate funds totaling \$50,000.00 for costs under the
30 purchase contract that will be incurred by the County in 2015; and

32 WHEREAS, the County Sheriff's Office will provide matching funds, in an amount
33 totaling \$50,000.00, from its Federal Law Enforcement Trust Fund toward the balance of the
34 costs that will be incurred by the County in 2015; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to authorize the County
38 Executive to execute the aforementioned purchase contract with Beacon Software Solutions,
39 Inc., subject to the approval of the Board of Control, upon the terms stated herein, and to
40 appropriate necessary funds;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The County Executive is hereby authorized to execute a purchase contract with Beacon
48 Software Solutions, Inc., subject to the approval of the Board of Control, for jail management
49 system software and support for a six-year term, at lower than State Term Pricing, for a total
50 amount not to exceed \$323,568.00 during the term.
