A Resolution authorizing the County Executive to execute a subgrant agreement with the Ohio Department of Job and Family Services and Ohio Department of Medicaid for grants received by Summit County Children Services, during State Fiscal Years 2016 and 2017, for the period 7/1/15 through 6/30/17, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing 7/1/08, the Ohio Department of Job and Family Services ("ODJFS") may only make grants to counties through subgrant agreements as described in that Section; and

WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, ODJFS developed a standard subgrant agreement to be executed by the commissioners or the executive of each county prior to receiving Department of Job and family Services grant funds; and

WHEREAS, effective with the term of the proposed subgrant agreement, the State has determined it necessary to add the Ohio Department of Medicaid ("ODM") to the agreement due to the County's receipt of funds from that agency; and

WHEREAS, Summit County Children Services ("SCCS") has received from ODJFS and ODM the standard subgrant agreement for State Fiscal Years ("SFY") 2016 and 2017 that sets forth the rights and responsibilities of both ODJFS, ODM and SCCS in relation to any grant that is awarded for SFY 2016 and 2017; and

WHEREAS, SCCS anticipates receiving grant funds from ODJFS for SFY 2016 and 2017; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive to execute the aforementioned subgrant agreement for SFY 2016 and 2017;
