7 **A Resolution authorizing the County Executive to submit to the State of Ohio a Request for**
8 **Designation to become a workforce development area with the Counties of Portage and**
9 **Medina, pursuant to Section 106 of the Workforce Innovation and Opportunity Act, for the**
10 **Executive's Department of Job and Family Services, and declaring an emergency.**

11
12 WHEREAS, pursuant to Section 106 of the Workforce Innovation and Opportunity Act
13 (the "Act"), the states are to designate local workforce development areas for the delivery of
14 workforce development activities as described in the Act; and

15
16 WHEREAS, the State of Ohio requires counties to request local workforce development
17 area designations under the Act before May 29, 2015; and

18
19 WHEREAS, the State of Ohio has encouraged counties to collaborate with surrounding
20 counties while proposing local workforce development area for the benefit of job seekers,
21 workers and businesses; and

23 WHEREAS, as required under the Act, the County Executive has reviewed all necessary
24 data to ensure that the proposed local workforce development area is:

- 25
- 26 • Consistent with labor market areas in the state;
 - 27 • Consistent with the regional economic development areas in the state;
 - 28 • Served by local educational agencies and intermediate educational agencies;
 - 29 • Served by postsecondary educational institutions and area career-technical
30 schools;
 - 31 • A geographic area that has available resources necessary to effectively administer
32 workforce development activities; and
 - 33 • A proposed area that will help a combination of local governments produce a
34 comprehensive workforce development system consistent with the goals of
35 Ohio's Unified State Plan; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that it is necessary and in the best interest of the County of Summit to authorize the County
39 Executive to submit to the State of Ohio a Request for Designation to become a workforce
40 development area with the Counties of Portage and Medina, pursuant to Section 106 of the Act;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

12 This Resolution is hereby declared an emergency in the interest of the health, safety and
13 welfare of the citizens of the County of Summit, and for the further reason to immediately
14 designate the local workforce development area before May 29, 2015 deadline from the State of
15 Ohio.

19 Provided this Resolution receives the affirmative vote of eight members, it shall take
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

25 It is found and determined that all formal actions of this Council concerning and relating
26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
27 deliberations of this Council and of any of its committees that resulted in such formal action,

29 121.22 of the Ohio Revised Code.
