7 **A Resolution confirming an award by the Board of Control of a super blanket purchase**
8 **order with Ports Petroleum Company, Inc., for gasoline and diesel fuel, under CUE**
9 **pricing, in an amount not to exceed \$100,000.00, for the Executive's Department of**
10 **Environmental Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 29, 2015, awarded a super
13 blanket purchase order with Ports Petroleum Company, Inc., for gasoline and diesel fuel, under
14 CUE pricing, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the super blanket purchase order is necessary and in the best interest of the County of
18 Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a super blanket purchase order with Ports
26 Petroleum Company, Inc., for gasoline and diesel fuel, under CUE pricing, in an amount not to
27 exceed \$100,000.00, is hereby confirmed and the County Executive is hereby authorized to
28 execute such super blanket purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide gasoline and diesel fuel in 2015.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
