7 **A Resolution authorizing the County Executive to execute an agreement of cooperation**  
8 **with the City of Fairlawn, for a joint grant application to the Akron Metropolitan Area**  
9 **Transportation Study, for the improvement of Cleveland-Massillon Road, partly in the**  
10 **County of Summit and partly in the City of Fairlawn, for the Engineer, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, the County Engineer and the City of Fairlawn agree that it would benefit the  
14 public health, safety and welfare to submit an application to the Akron Metropolitan Area  
15 Transportation Study ("AMATS") for federal funding for the proposed widening and  
16 improvement of Cleveland-Massillon Road starting from just south of Ridge Park Drive and  
17 ending at the existing five-lane section near the Giant Eagle store north of Brookwall Drive and  
18 providing for the milling and repaving of Cleveland-Massillon Road beginning at the existing  
19 five-lane section near the Giant Eagle and proceeding north to Route 18 (the "Project"), in  
20 Council District 2; and

21  
22 WHEREAS, approximately 80% of this portion of Cleveland-Massillon Road lies within  
23 the jurisdiction of the City of Fairlawn and approximately 20% of this portion of Cleveland-  
24 Massillon-Road lies within the jurisdiction of Summit County; and

25  
26 WHEREAS, the County Engineer and the City of Fairlawn agree to cooperate in  
27 submitting a joint application for the Project to AMATS in time to apply for funding for roadway  
28 improvements funded by grants awarded in State Fiscal Years 2021 and 2022; and

30 WHEREAS, the City of Fairlawn approved entering into said agreement on May 4, 2015,  
31 via Fairlawn City Council Ordinance No. 2015-0218; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
34 that it is necessary and in the best interest of the County of Summit to authorize the County  
35 Executive to execute an agreement of cooperation with Fairlawn to submit a grant application to  
36 AMATS for the widening and improvement of Cleveland-Massillon Road;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that;

41 SECTION 1

43 The County Executive is hereby authorized to execute an agreement of cooperation with  
44 the City of Fairlawn, whereby the County and Fairlawn will submit a grant application to Akron  
45 Metropolitan Area Transportation Study ("AMATS") for the improvement and widening of  
46 Cleveland-Massillon Road, in Council District 5. A copy of said agreement is attached hereto as  
47 Exhibit A and incorporated herein as if fully restated.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
8 allow the Executive to execute said agreement and allow the Engineer and the City of Fairlawn  
9 to apply for funding from AMATS.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,
