A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of Summit, authorizing purchases by the Court of Common Pleas General Division from the Community Health Center, as Best Practical Source, for drug screen testing services, in a total aggregate amount not to exceed \$72,000.00, in calendar year 2015, for the Court of Common Pleas General Division – Adult Probation Department, and declaring an emergency.

WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar year, where no additional competitive quotes or bids have been taken, shall be made only upon authorization of County Council; and

WHEREAS, the Executive's Department of Finance and Budget and the Board of Control have previously approved purchases by the Court of Common Pleas General Division – Adult Probation Department from the Community Health Center, as Best Practical Source, for drug screen testing services, in the aggregate amount of \$15,486.00, in calendar year 2015; and

WHEREAS, the Court of Common Pleas General Division – Adult Probation Department anticipates additional purchases from the Community Health Center, as Best Practical Source, for drug screen testing services, in an additional amount not to exceed \$56,514.00, for a total aggregate amount not to exceed \$72,000.00, in calendar year 2015; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize purchases by the Court of Common Pleas General Division – Adult Probation Department from the Community Health Center, as Best Practical Source, for drug screen testing services, in a total aggregate amount not to exceed \$72,000.00, in calendar year 2015;
