A Resolution authorizing the County Executive to execute any documents necessary to accept the award by the Ohio Department of Youth Services of a Behavioral Health and Juvenile Justice grant, for the period 7/1/15 through 6/30/16, in the amount of \$385,720.00, with a local cash or in-kind match of \$115,385.00, and appropriating grant funds, for the Court of Common Pleas – Juvenile Division, and declaring an emergency.

WHEREAS, the Court of Common Pleas – Juvenile Division has been awarded a Behavioral Health and Juvenile Justice ("BHJJ") grant from the Ohio Department of Youth Services for the funding of a local collaborative in providing services to youths with behavioral needs, in the amount of \$385,720.00; and

WHEREAS, this grant requires a local match of \$115,385.00 of cash/or in-kind service; and

WHEREAS, this funding is to continue the support of the Integrated Co-occurring Treatment and Trauma Focused Cognitive Behavioral Therapy, in addressing those issues for both the serious juvenile offender youth and their families, with the ultimate goal to positively affect behavior, improve coping skills, provide safe and healthy alternatives, and prepare these youth and families to function positively and productively in the home and community; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute any documents necessary to accept the award of the aforementioned BHJJ grant from the Ohio Department of Youth Services, and to appropriate grant funds;
