An <u>amended</u> Ordinance amending certain sections of Chapter 169 of the Codified Ordinances of the County of Summit, entitled "Personnel Policies and Procedures," and enacting new Section 169.33 of the Codified Ordinances, for the Executive's Department of Human Resources and the Human Resource Commission, and declaring an emergency.

WHEREAS, after a review by the County Executive's Department of Human Resources and the Human Resource Commission Administrator, it was determined that it is necessary to make certain changes to Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25 and 169.28 through 169.32 of the Codified Ordinances of the County of Summit, and to enact new Section 169.33 of the Codified Ordinances, entitled "Report of Violation of Statutes or Rules by Employee;" and

WHEREAS, it is necessary for County Council to adopt legislation implementing the recommended revisions to the aforementioned sections of Chapter 169 and to enact new Section 169.33; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary to amend Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25, and 169.28 through 169.32 of the Codified Ordinances of the County of Summit, and to enact new Section 169.33 of the Codified Ordinances;

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25 and 169.28 through 169.32 of the Codified Ordinances of the County of Summit are hereby amended and new Section 169.33 of the Codified Ordinances, entitled "Report of Violation of Statutes or Rules by Employee;" is hereby amended, as shown on <u>Amended Exhibit A</u>, attached hereto and incorporated herein as if fully restated.

SECTION 2

This Ordinance is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason of immediately amending Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25 and 169.28 through 169.32 of the Codified Ordinances of the County of Summit and enacting new Section 169.33 of the Codified Ordinances in order to immediately implement a more efficient human resource system in the County.

SECTION 3
