8 **A Resolution authorizing the County Executive to execute Change Order No. 1 to an intra-**
9 **governmental agreement with the County Executive's Department of Job and Family**
10 **Services for the Youth Employment for Success 2015 Summer Youth Employment**
11 **Program and appropriating funds, in the amount of \$64,982.00, for the period 5/1/15**
12 **through 9/30/15, for the Executive's Department of Communications, and declaring an**
13 **emergency.**

15 WHEREAS, this Council previously adopted Resolutions No's. 2015-177 and 2015-225
16 confirming and appropriating an award from Executive's Department of Job and Family Services
17 ("DJFS") of Temporary Assistance to Needy Families ("TANF") funds from the Ohio
18 Department of Job and Family Services for the 2015 Summer Youth Program; and

20 WHEREAS, the Board of Control, at its meeting held May 27, 2015, awarded Change
21 Order No. 1 to an intra-governmental agreement between County Executive's Department of
22 Communications and DJFS, for additional supervisors to provide enhanced oversight at youth
23 worksites and assistance with timesheet collection and review to ensure timely and accurate
24 payroll submissions for the Youth Employment for Success 2015 Summer Youth Employment
25 Program, for the period 5/1/15 through 9/30/15, in an amount not to exceed \$64,982.00 (63.01%
26 increase) in TANF funds; and

28 WHEREAS, it is necessary to authorize the County Executive to execute, on behalf of the
29 Department of Communications, Change Order No. 1 to the intergovernmental agreement with
30 DJFS and to appropriate TANF funds, in the amount of \$64,982.00; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorizing the Executive
34 to execute, on behalf the Department of Communications, Change Order No. 1 to the intra-
35 governmental agreement with DJFS and to appropriate TANF funds;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

43 Department of Communications, Change Order No. 1 to an intra-governmental agreement with
44 the Executive's Department of Job and Family Services, for additional supervisors to provide
45 enhanced oversight at youth worksites and assistance with timesheet collection and review to
46 ensure timely and accurate payroll submissions for the Youth Employment for Success ("YES")
47 2015 Summer Youth Employment Program, for the period 5/1/15 through 9/30/15, in an amount
48 not to exceed \$64,982.00 (63.01% increase).

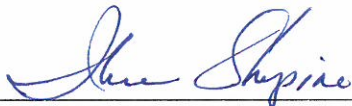
