7 **A Resolution authorizing the County Executive to advertise for bids for the Courthouse**  
8 **Window Painting Project, for an estimated total cost not to exceed \$136,600.00, for the**  
9 **Executive's Department of Administrative Services – Physical Plants, and declaring an**  
10 **emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the Courthouse  
16 Window Painting Project, for the painting and repair of the windows at the Summit County  
17 Courthouse, in Council District 4, for an estimated total cost not to exceed \$136,600.00; and

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for the Courthouse Window Painting Project, in Council District 4;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for the Courthouse Window  
31 Painting Project, for the painting and repair of the windows at the Summit County Courthouse, in  
32 Council District 4, for an estimated total cost not to exceed \$136,600.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
37 of the citizens of the County of Summit, and for the further reason that it authorizes the  
38 Executive to immediately advertise for bids for Courthouse Window Painting Project, in Council  
39 District 4.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
