7 **A Resolution confirming an award by the Board of Control of a 60-month lease with**  
8 **ComDoc, Inc. for eight Xerox copiers under Northeast Ohio Sourcing Office pricing, for a**  
9 **total amount not to exceed \$50,580.00, for the Prosecutor's Child Support Enforcement**  
10 **Agency, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 27, 2015, awarded a 60-  
13 month lease with ComDoc, Inc. for eight Xerox copiers under Northeast Ohio Sourcing Office  
14 pricing, for an amount not to exceed \$843.00 per month or an amount not to exceed \$10,116.00  
15 per year, for a total amount not to exceed \$50,580.00 during the 60-month term of the lease,  
16 approved by the Information and Technology Board on 5/26/15, subject to confirmation by  
17 County Council; and

19 WHEREAS, the lease with ComDoc, Inc. is exempt from competitive bidding as a  
20 contract for equipment through any other public cooperative purchasing associations, including,  
21 but not limited to, the Northeast Ohio Sourcing Office, pursuant to Section 177.07(a)(11) of the  
22 Codified Ordinances of the County of Summit; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that the aforementioned lease with ComDoc, Inc. is necessary and in the best interest of the  
26 County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The award by the Board of Control of a 60-month lease with ComDoc, Inc. for eight  
34 Xerox copiers under Northeast Ohio Sourcing Office pricing, for an amount not to exceed  
35 \$843.00 per month or an amount not to exceed \$10,116.00 per year, for a total amount not to  
36 exceed \$50,580.00 during the 60-month term of the lease, approved by the Information and  
37 Technology Board on 5/26/15, is hereby confirmed and the County Executive is hereby  
38 authorized to execute such lease.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit, and for the further reason to immediately  
44 provide for a necessary lease of copiers for the Prosecutor's Child Support Enforcement Agency.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
