7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Child Guidance and Family Solutions to provide prevention and intervention**  
9 **services for preschool aged children, for the period 10/1/15 through 9/30/16, in an amount**  
10 **not to exceed \$85,000.00, for the Executive's Department of Job and Family Services, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 15, 2015, awarded a  
14 professional service contract with Child Guidance and Family Solutions to provide prevention  
15 and intervention services for preschool aged children who exhibit behavioral problems in a child  
16 care setting which could result in expulsion and inhibit parents' ability to maintain employment,  
17 for the period 10/1/15 through 9/30/16, in an amount not to exceed \$85,000.00, subject to  
18 confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned professional service contract is necessary and in the best interest of the  
22 County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a professional service contract with Child  
30 Guidance and Family Solutions to provide prevention and intervention services for preschool  
31 aged children who exhibit behavioral problems in a child care setting which could result in  
32 expulsion and inhibit parents' ability to maintain employment, for the period 10/1/15 through  
33 9/30/16, in an amount not to exceed \$85,000.00, is hereby confirmed and the County Executive  
34 is hereby authorized to execute such professional service contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason to immediately  
40 provide prevention and intervention services for preschool aged children effective 10/1/15.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.

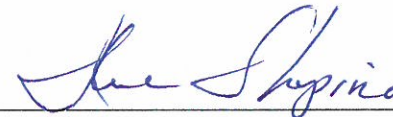

10 121.22 of the Ohio Revised Code.

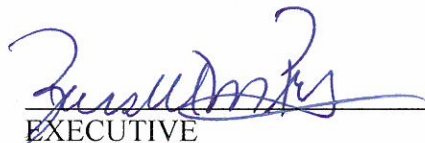
