7 **A Resolution increasing appropriations in the Delinquent Tax Fund, in the amount of**
8 **\$100,000.00, through 12/31/15, for the Fiscal Officer, and declaring an emergency.**

10 WHEREAS, the Delinquent Tax Fund is used to pay mandatory costs on behalf of
11 municipalities associated with nonproductive land sales, including court costs, title work and
12 advertising; and

14 WHEREAS, these mandatory costs are reimbursed to the County on the semi-annual real
15 estate settlements; and

17 WHEREAS, an increase in appropriations in the Delinquent Tax Fund is necessary to
18 cover mandatory costs for 2015;

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to increase appropriations in
22 the Delinquent Tax Fund, in the amount of \$100,000.00, through 12/31/15;
