7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a grant from FirstEnergy Corporation, for the purpose of providing a variety of**
9 **energy efficiency education and repair services to qualified residents, for the program**
10 **period 6/1/15 through 5/31/16, in the amount of \$185,000.00, with no local cash match**
11 **requirement, for the Executive's Department of Community and Economic Development,**
12 **and declaring an emergency.**

14 WHEREAS, the County of Summit has been awarded a grant from FirstEnergy
15 Corporation, awarded by the Ohio Partners for Affordable Energy, for the purpose of providing a
16 variety of energy efficiency education and repair services to qualified residents through the
17 County's Home Weatherization Assistance Program ("HWAP"), for the program period 6/1/15
18 through 5/31/16, in the amount of \$185,000.00, with no local cash match requirement; and

19
20 WHEREAS, the FirstEnergy funds are used to supplement HWAP funds required to
21 perform repairs not covered by HWAP funds, such as electrical repairs, and the expectation for
22 the entire program is to complete 98 units for Program Year 2016 with an average cost per unit
23 of \$6,987.00; and

25 WHEREAS, it is necessary to authorize the County Executive to execute any documents
26 necessary to accept the aforementioned grant from FirstEnergy Corporation and to appropriate
27 the grant funds; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 execute any documents necessary to accept the aforementioned grant from FirstEnergy
32 Corporation, in the amount of \$185,000.00, with no local cash match requirement;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State


