A Resolution confirming an award by the Board of Control of a professional service contract with Akron General Medical Center for Biometric Screening services and flu shots for County employees, for a one-year term, from June 1, 2015 through May 31, 2016, in an amount not to exceed \$33,715.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, the County requires Biometric Screening services and flu shots for County employees for its health fair and flu shot clinics and after sending out requests for proposals, selected Akron General Medical Center as the lowest responsive and responsible bidder; and

WHEREAS, the County anticipates a cost of \$13,715.00 for Biometric Screening services and \$20,000.00 for flu shots for an estimated 800 flu shots at \$25 per flu shot, for an amount not to exceed \$33,715.00; and

WHEREAS, the Board of Control, at its meeting held July 29, 2015, awarded a professional service contract with Akron General Medical Center for Biometric Screening services and flu shots for County employees, for a one-year term, from June 1, 2015 through May 31, 2016, in an amount not to exceed \$33,715.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Akron General Medical Center is necessary and in the best interest of the County of Summit;
