7 **A Resolution authorizing the County Executive to execute agreements and any other**
8 **documents necessary for inter-county transfers of surplus funds between the Executive's**
9 **Department of Job and Family Services and the Union County Department of Job and**
10 **Family Services, pursuant to which agreements Summit County will transfer \$40,000.00 in**
11 **surplus funds to Union County and accept \$67,871.00 in surplus funds from Union County**
12 **and adjust appropriations to reflect these transfers, for the Executive's Department of Job**
13 **and Family Services, and declaring an emergency.**

15 WHEREAS, Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to
16 execute a JFS 02719 "Inter-county Agreement and Certification and Release and Acceptance of
17 Funds" to engage in inter-county transfers of surplus funds allocated to county departments of
18 job and family services by the Ohio Department of Job and Family Services; and

19
20 WHEREAS, Summit County and Union County wish to enter into an agreement pursuant
21 to Section 5101:9-6-82 pursuant to which Summit County will transfer \$40,000.00 in surplus
22 Title XX Base funds to Union County and accept \$67,871.00 in surplus Temporary Assistance to
23 Needy Families Administration funds from Union County, and adjust appropriations to reflect
24 these transfers; and

26 WHEREAS, it is necessary to authorize the County Executive to execute the
27 aforementioned agreement with Union County and any other necessary documents pursuant to
28 Section 5101:9-6-82 to implement said inter-county transfers and acceptances of surplus funds
29 between the counties' respective departments of job and family services; and

31 WHEREAS, it is further necessary to appropriate said surplus funds received by the
32 County Executive's Department of Job and Family Services ("SCDJFS") as stated above; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
36 execute the aforementioned agreements with Union County and any other necessary documents
37 pursuant to Section 5101:9-6-82 to implement said inter-county transfers and acceptances of
38 surplus funds between the counties' respective departments of job and family services and to
39 appropriate said surplus funds received by SCDJFS;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The County Executive is hereby authorized to execute agreements and any other
47 necessary documents pursuant to Section 5101:9-6-82 of the Ohio Administrative Code for inter-
48 county transfers of surplus funds between the Executive's Department of Job and Family
49 services ("SCDFS") and the Union County Department of Job and Family Services, pursuant to
50 which Summit County will transfer \$40,000.00 in surplus Title XX Base funds to Union County
51 and accept \$67,871.00 in surplus Temporary Assistance to Needy Families Administration funds
52 from Union County, and adjust appropriations to reflect these transfers.
