7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Asian Services in Action, Inc., for onsite employment services for refugee**
9 **clients, for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed**
10 **\$41,400.00, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 12, 2015, awarded a
14 professional service contract with Asian Services in Action, Inc., for onsite employment services
15 for refugee clients participating in the Summit County Occupational Preparation Experience
16 program at OhioMeansJobs Summit County fka The Job Center, for a one-year term, from
17 10/1/15 through 9/30/16, in an amount not to exceed \$41,400.00, subject to confirmation by
18 County Council; and

20 WHEREAS, pursuant to Section 5101:9-4-07(A)(2) of the Ohio Administrative Code,
21 which conforms to Federal regulations, the services to be provided by Asian Services in Action,
22 Inc., which will be funded by Temporary Assistance for Needy Families grant funds, are exempt
23 from competitive bidding requirements due to Asian Services in Action, Inc.'s status as a
24 subgrantee; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned professional service contract with Asian Services in Action, Inc. is
28 necessary and in the best interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a professional service contract with Asian Services
36 in Action, Inc., for onsite employment services for refugee clients participating in the Summit
37 County Occupational Preparation Experience program at OhioMeansJobs Summit County fka
38 The Job Center, for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed
39 \$41,400.00, is hereby confirmed and the County Executive is hereby authorized to execute such
40 professional service contract.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit, and for the further reason to immediately
46 provide for onsite employment services for refugee clients effective 10/1/15.

51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
